Membership Investment Guideline

Membership in the Maui Chamber of Commerce is based upon a fair-share investment. Our members have indicated that the number of employees is the fairest measure of business size for most industries. (The accommodations industry is based upon number of rooms.)

How to Compute your Chamber Dues:

Employee Basis: The base rate is \$284.35 for up to 5 employees with an additional \$9.10 per employee over 5 employees. For example, a firm has 12 full time employees:
